

2017 TERMS & CONDITIONS OF HOSPITALITY

NZ Trotting Cup Day and Show Day Races

Please read these terms and conditions carefully before purchasing tickets.

By purchasing tickets, completing a booking form or attending the NZ Trotting Cup Day or Show Day Races, you are agreeing to be bound by the following terms and conditions:

1.0 Agreement

- 1.1 A binding agreement between Addington Raceway Ltd (ARL) and the client is effective upon ARL receiving a completed booking form and/or the client meeting the payment terms as required.
- 1.2 Bookings are subject to the availability of the requested facility and will not be reserved or confirmed until a completed booking form and/or full payment is received.
- 1.3 NZ Trotting Cup Day or Show Day Races cancellations received prior to 1 September 2017 will result in a 50% cancellation fee. Any cancellations received from 1 September 2017 onwards will result in a 100% cancellation fee. A cancellation constitutes a reduction in numbers or a full cancellation of the booking.

2.0 Payment

- 2.1 All bookings for hospitality packages must be accompanied by full payment in the form of a cheque, direct credit, cash or by credit card.
- 2.2 Please note that a deposit is required to secure your booking. Entry tickets will not be issued until full payment is received.

3.0 Issue of tickets

- 3.1 Tickets will be forwarded by post or courier upon receipt of full payment after 1 October 2017. Tickets will not be posted for payments received within fourteen (14) days of the event. These will need to be collected from the ARL Offices between 8.30am and 4.30pm Monday to Friday (except Monday 13 and Tuesday 14 November in which the office will be closed and tickets can be collected from the Ticketek office based at Horncastle Arena).

- 3.2 The issue of tickets to a particular facility does not permit entry to any other private facility. However, you may access and utilise public areas.
- 3.3 ARL will not accept responsibility for misplaced, lost or stolen tickets previously issued. Any replacement tickets will be issued at the sole discretion of ARL, and ARL reserves the right to charge for the replacement of any tickets issued.
- 3.4 Correct tickets must be displayed at all times and / or on request. Failure to comply will result in entry being refused or removal from the venue.

4.0 Changes to New Zealand Trotting Cup Day

- 4.1 Some venues are outdoors. In such cases, no alternative facilities are available in the event of unfavourable weather.
- 4.2 If the NZ Trotting Cup Day hospitality is cancelled prior to the advertised opening time, ARL will refund to the client the purchase price (less part or all of the cost incurred as reasonably determined by ARL).
- 4.3 Due to unforeseen circumstances it may be necessary for ARL to reschedule the NZ Trotting Cup Day. If the need arises ARL will either;
 - a) refund to the client the purchase price (less part or all of the cost incurred as reasonably determined by ARL), or
 - b) provide the client with equivalent or similar facility for the postponed date (if available), or
 - c) where there is a relocation of events and ARL cannot provide an equivalent or similar facility to the client's facility at the alternative venue, ARL will refund to the client the purchase price (less part or all of the cost incurred as reasonably determined by ARL).
- 4.4 Programmes, menus and the duration and timing of entertainment, events and other activities on NZ Trotting Cup Day may be subject to alteration without notice. ARL reserves the right to vary, add, withdraw or substitute advertised programmes, menus, seating arrangements and / or facilities at any time.
- 4.5 Under no circumstances will ARL be liable to the client if ARL is unable to perform its obligations to the client, due to any event or cause of force majeure being any event or act beyond the control of ARL.
